Caveat for Gun Safe data

*Gun Safe data does **not** include paper-based applications. Paper based applications represent 2.5% of all transactions. Average processing times for paper-based applications are longer than online applications due to delays associated with postage and manual handling. All licence holders are encouraged to use the Gun Safe system wherever possible.*

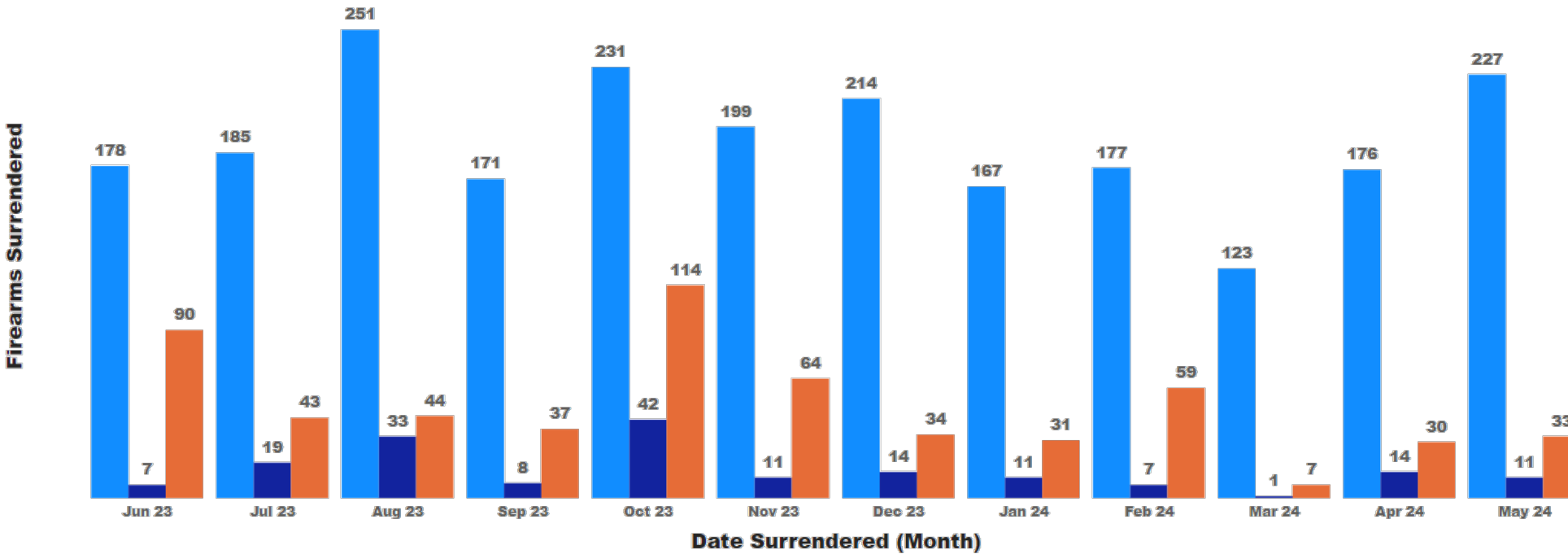

Total Firearms handed in during Amnesty from 1 July 2021:

- 9441 handed in to Dealers
- 3732 handed in to Police of which 804 were handed to Police by Gun Safe Dealers for destruction/disposal

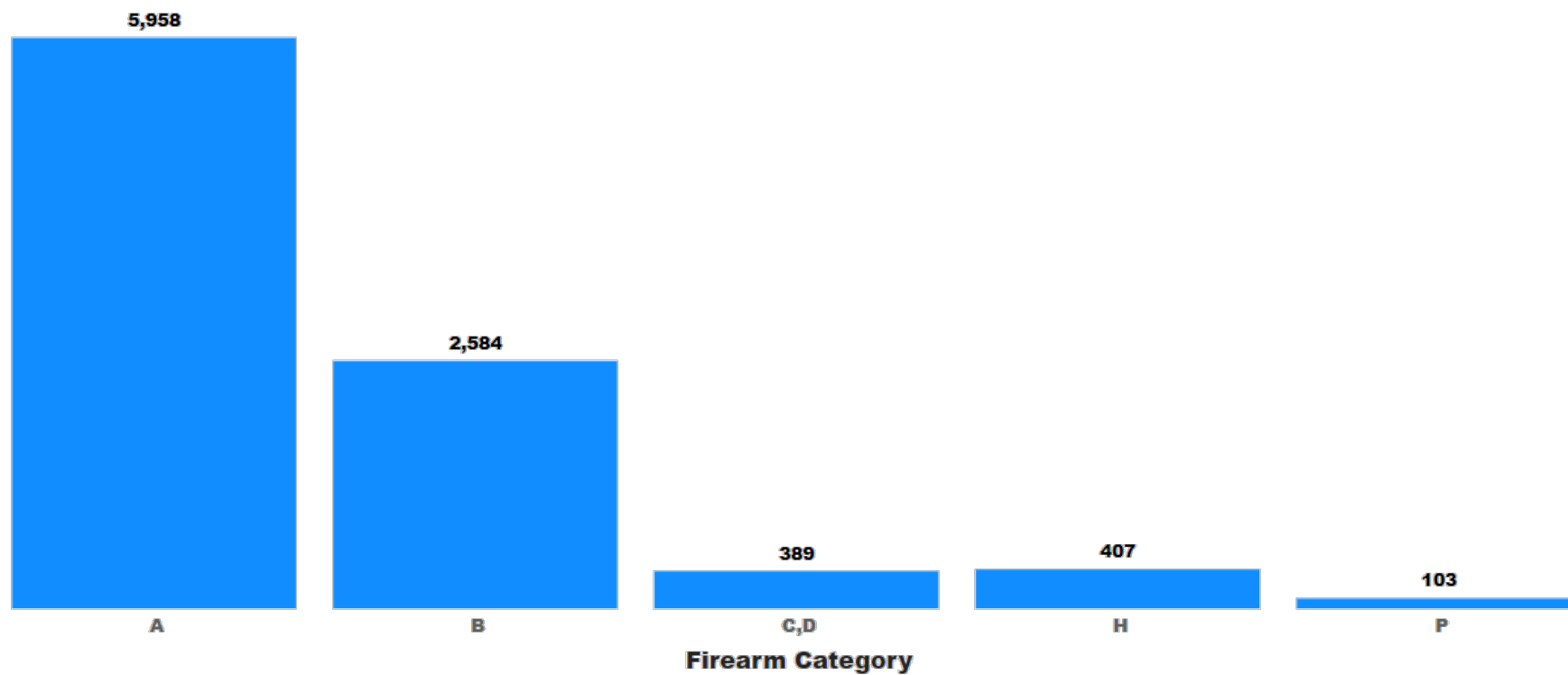

Total surrendered to Dealers by category to May 2024 = 9441 firearms

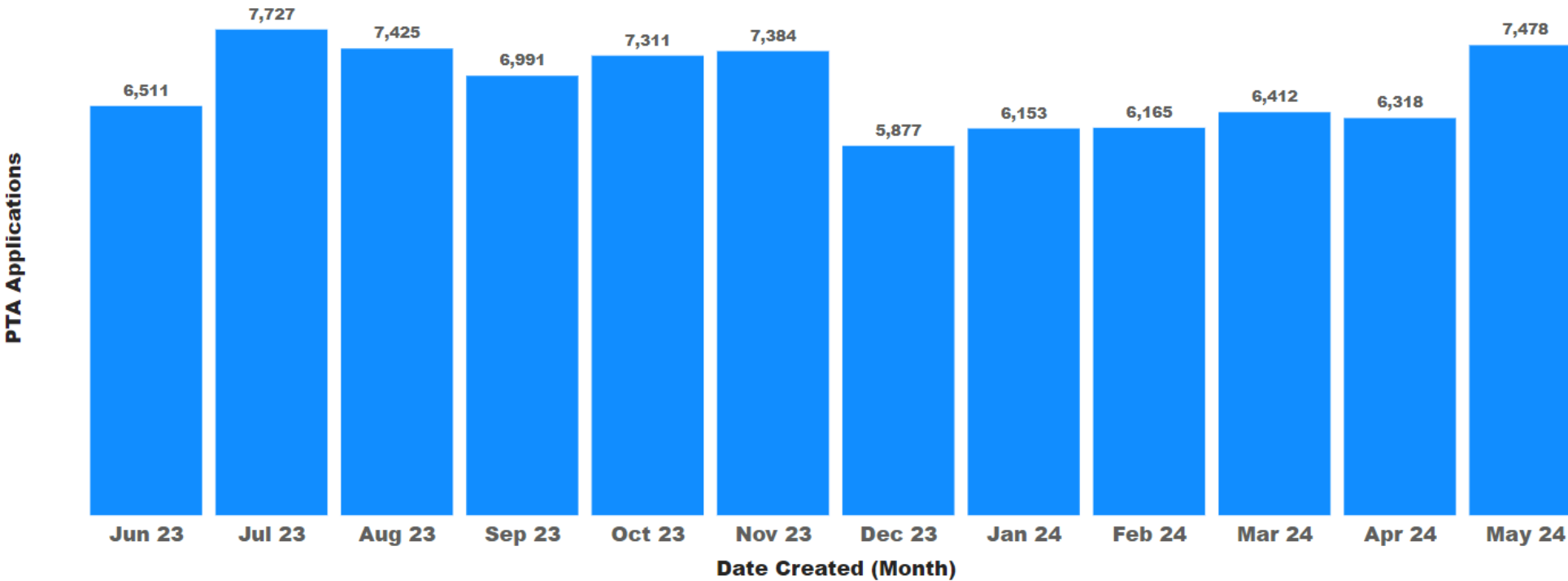

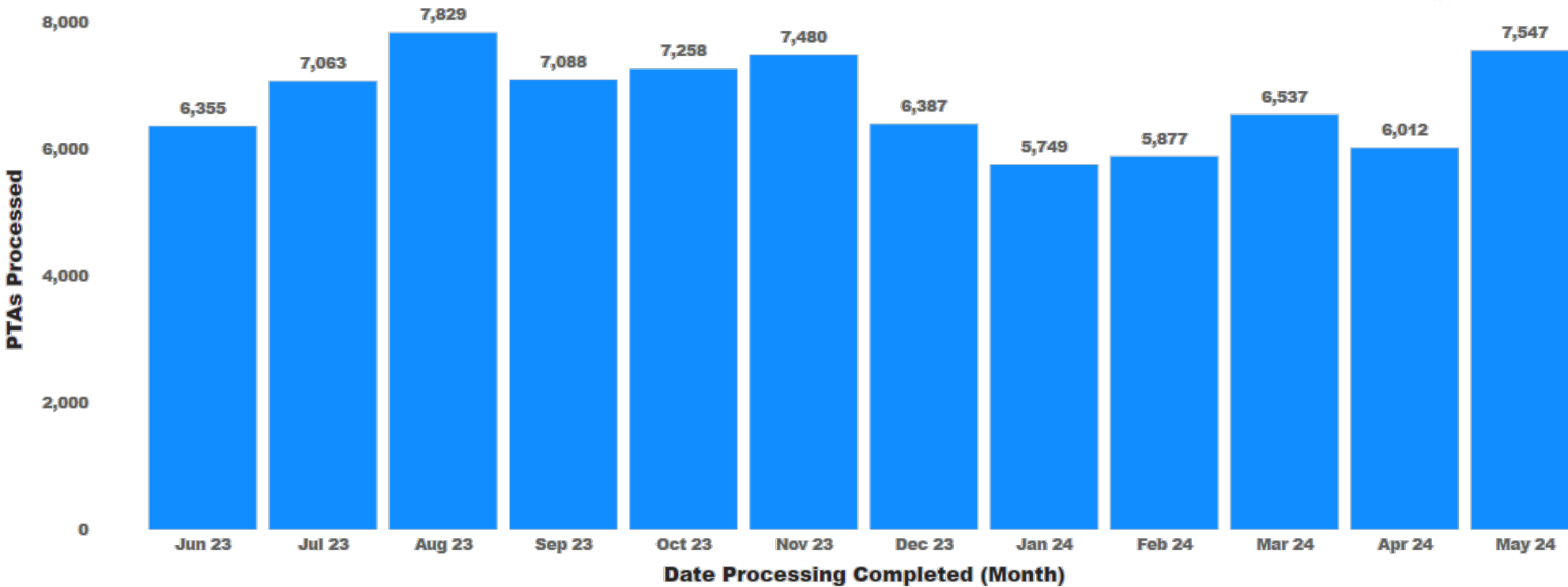

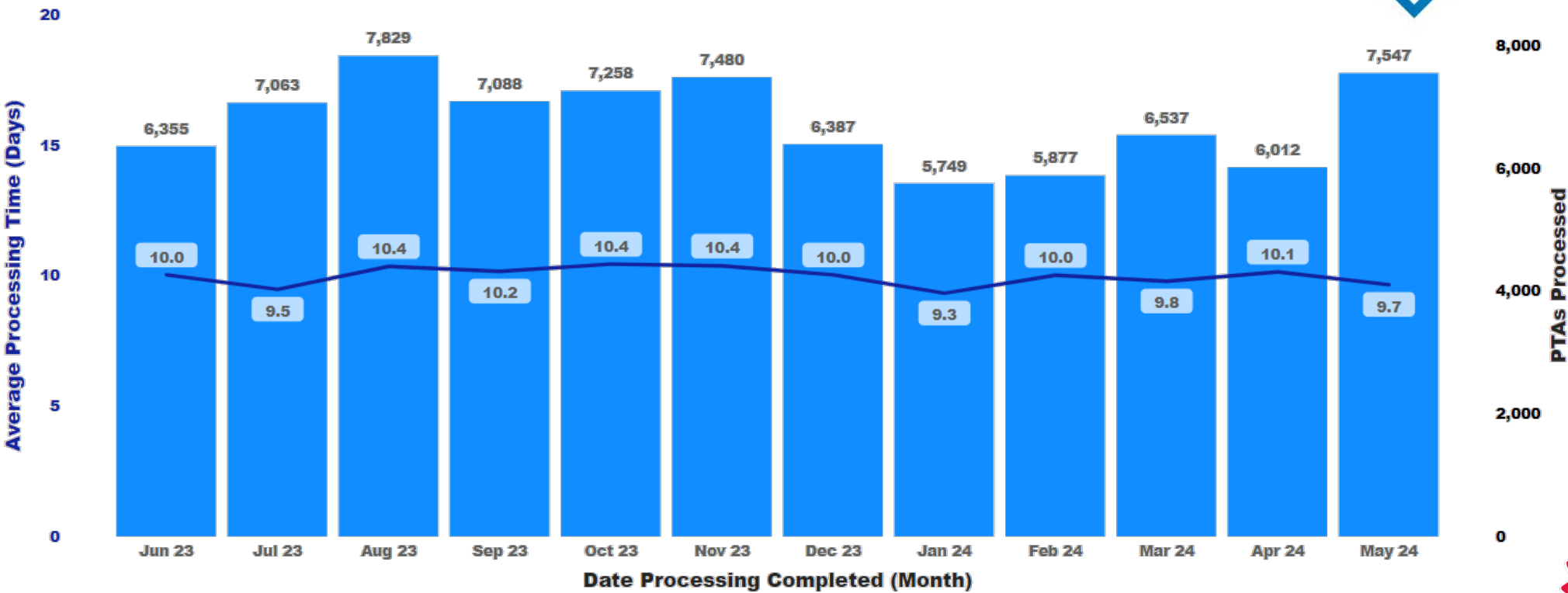

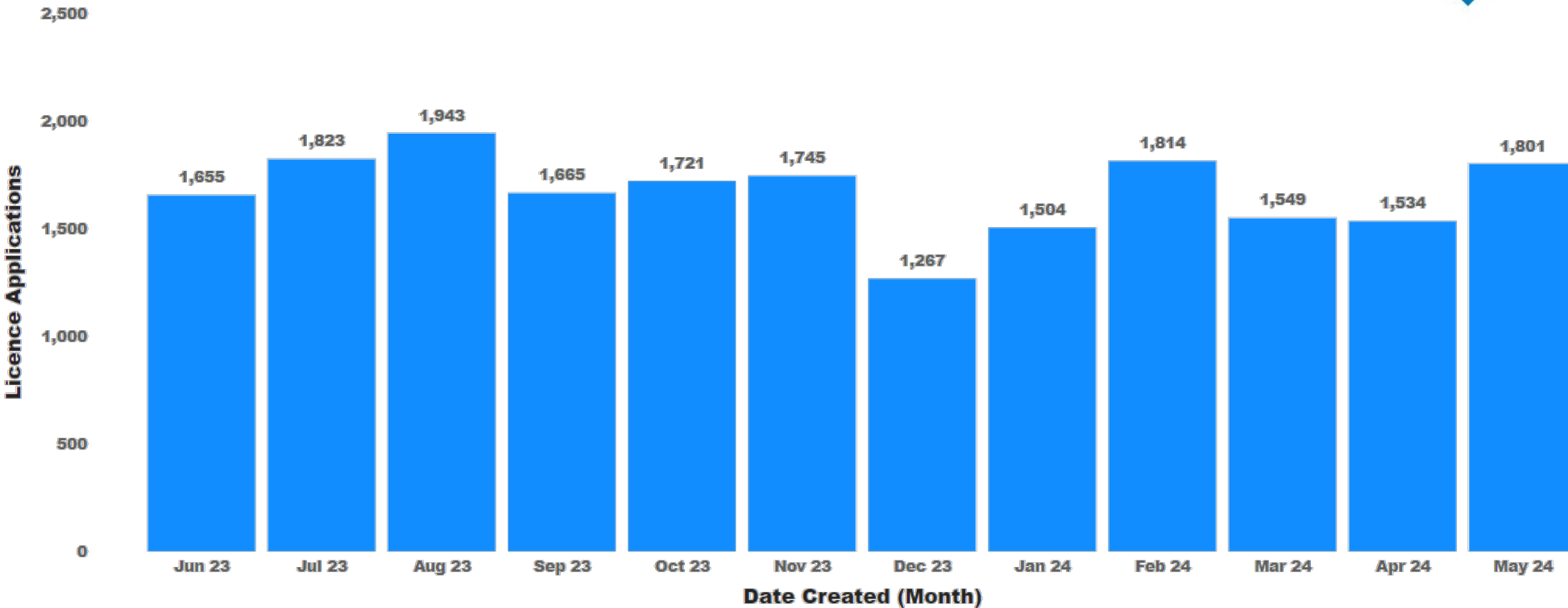

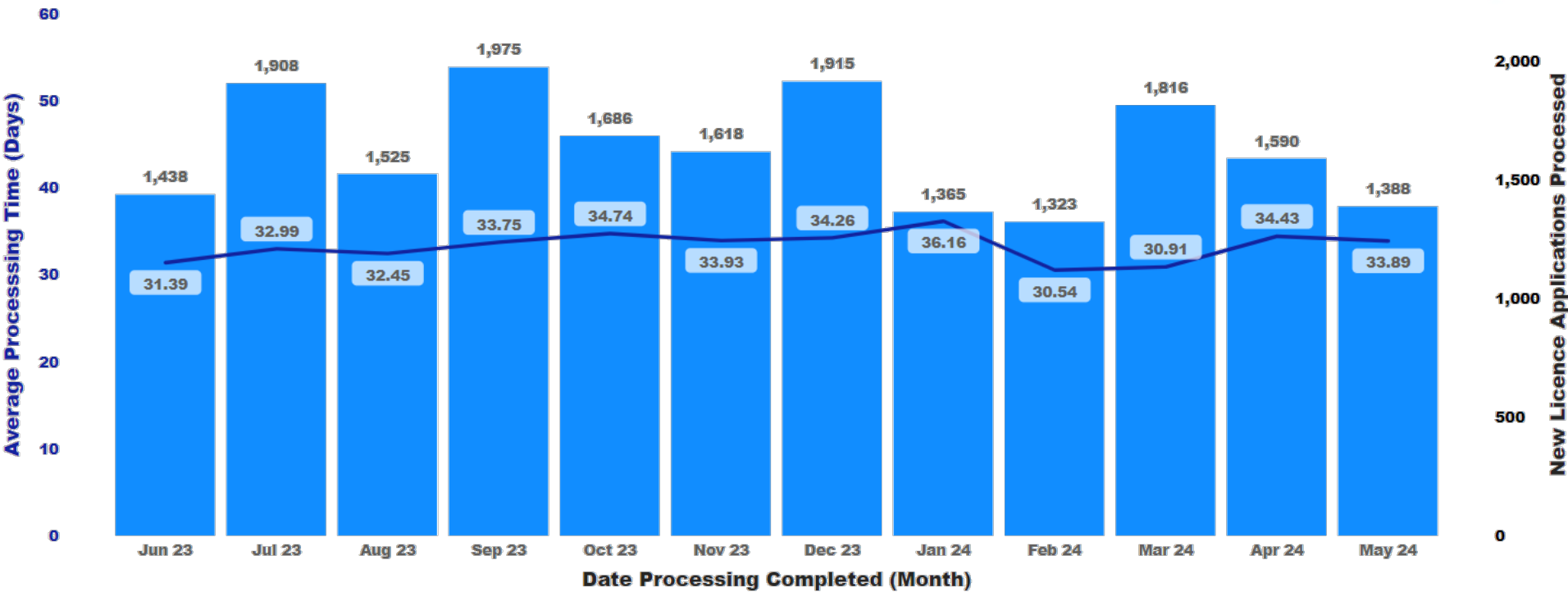

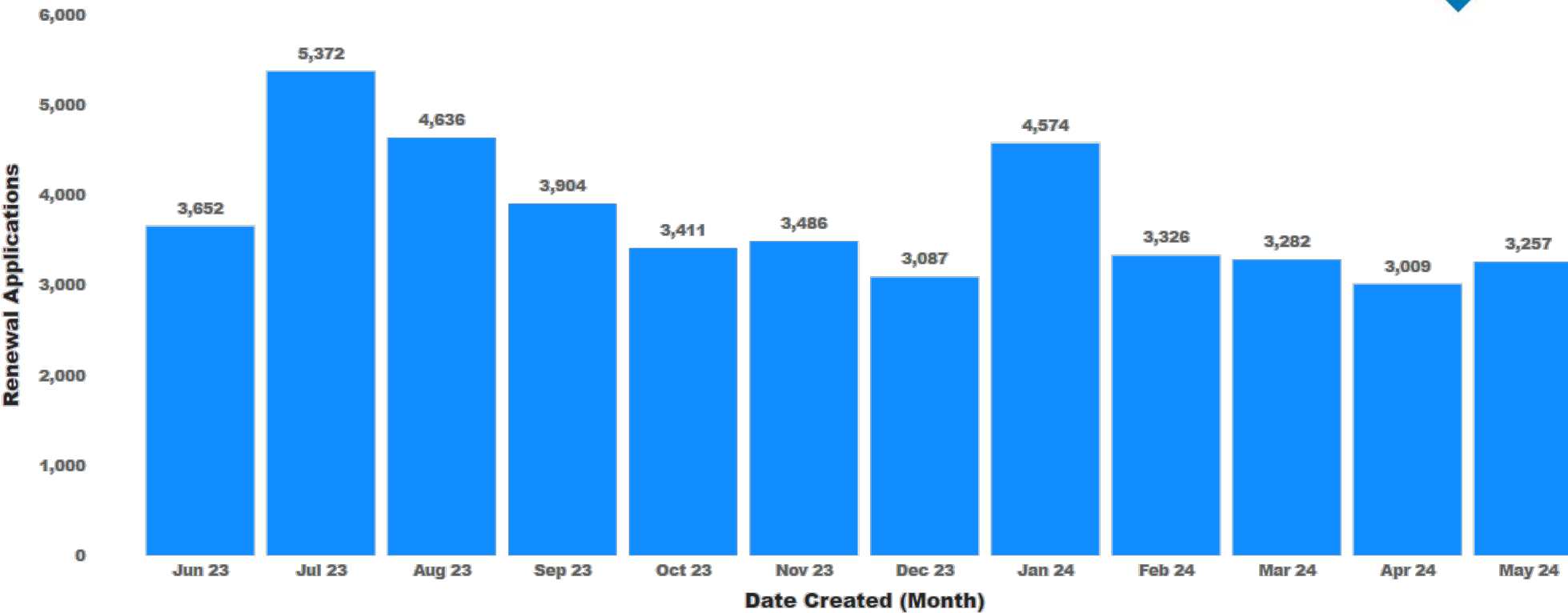

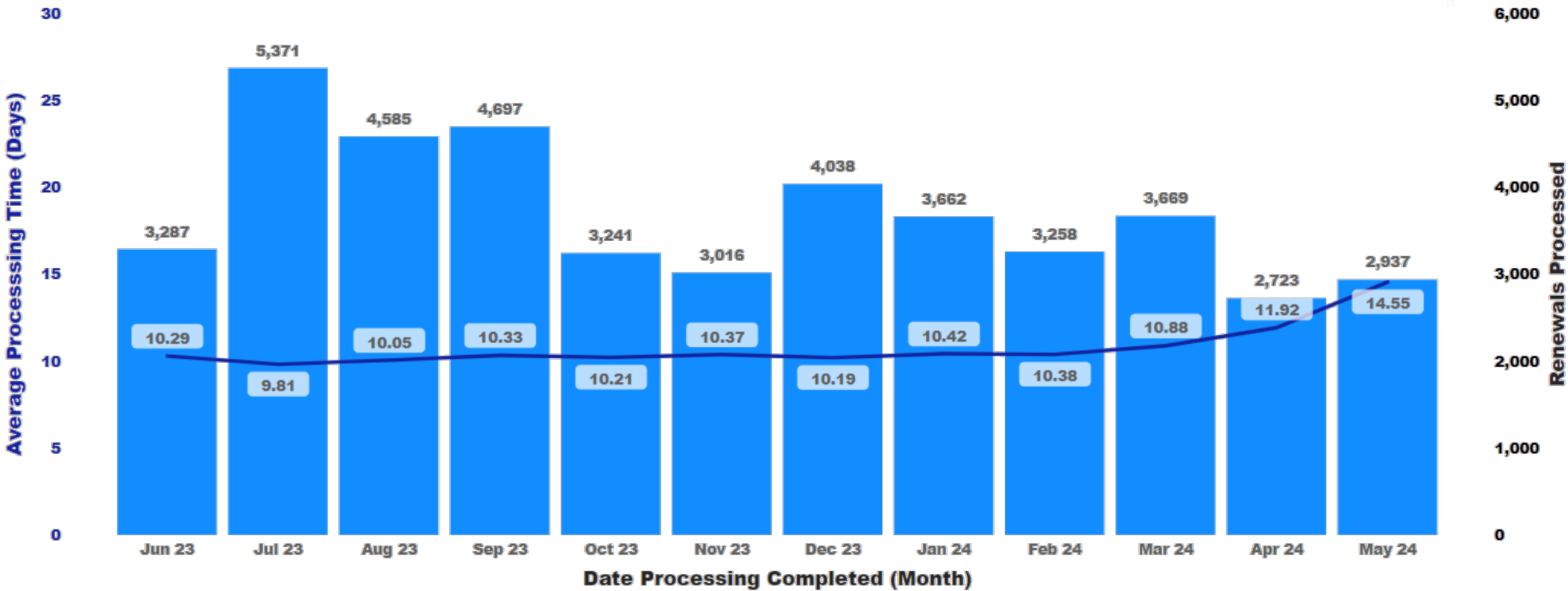

Average Processing Time & Renewal Applications Processed per Month

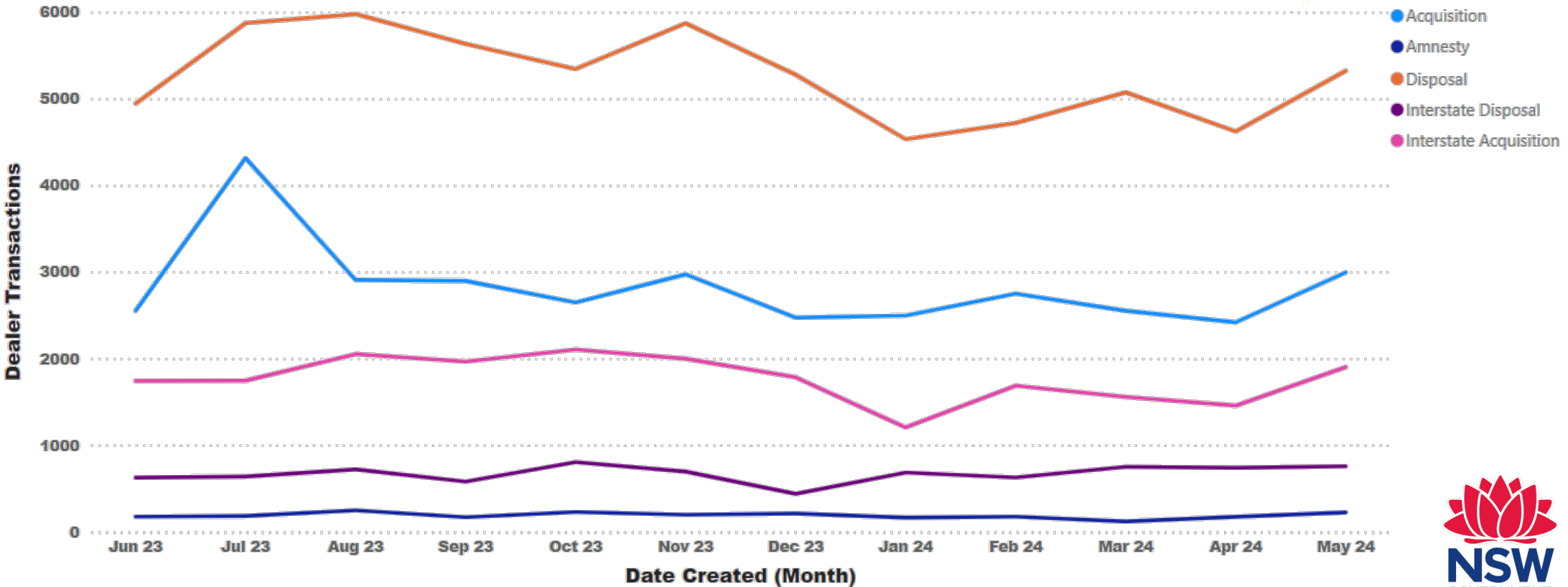

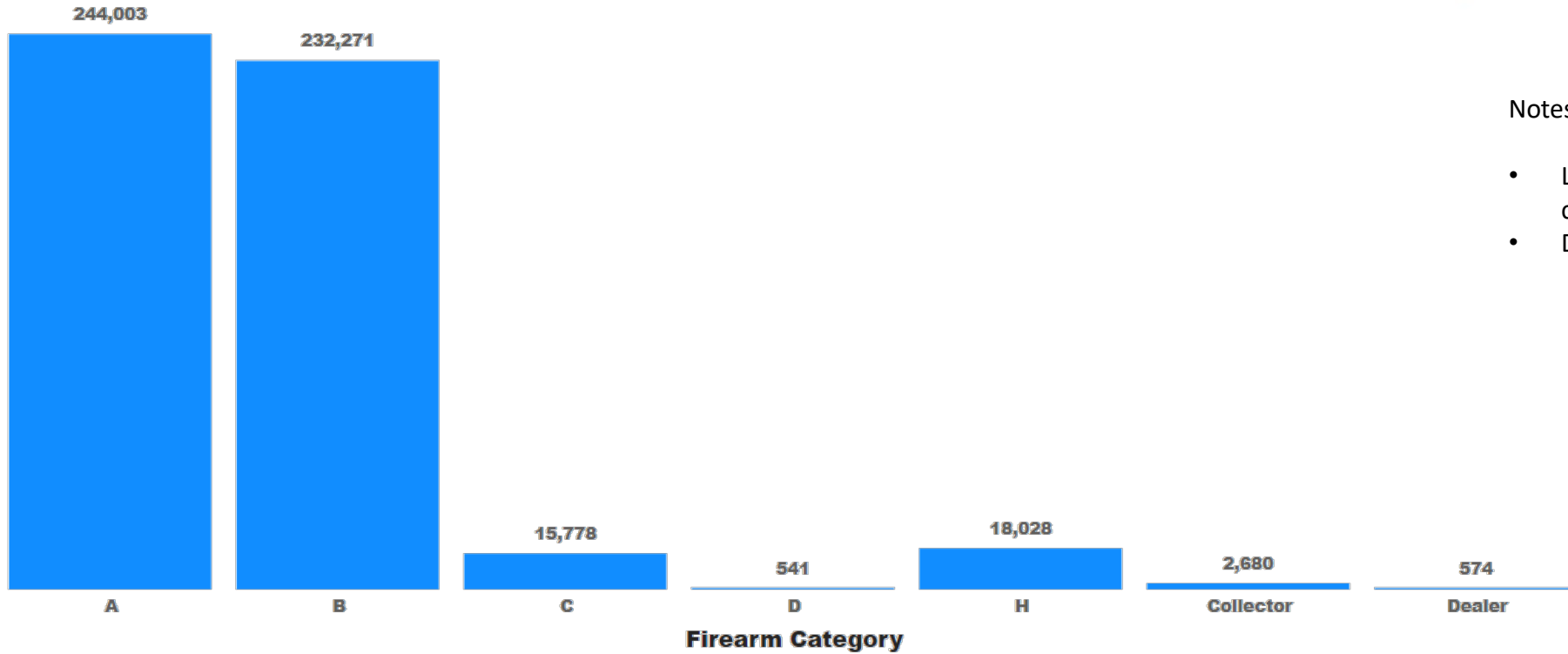

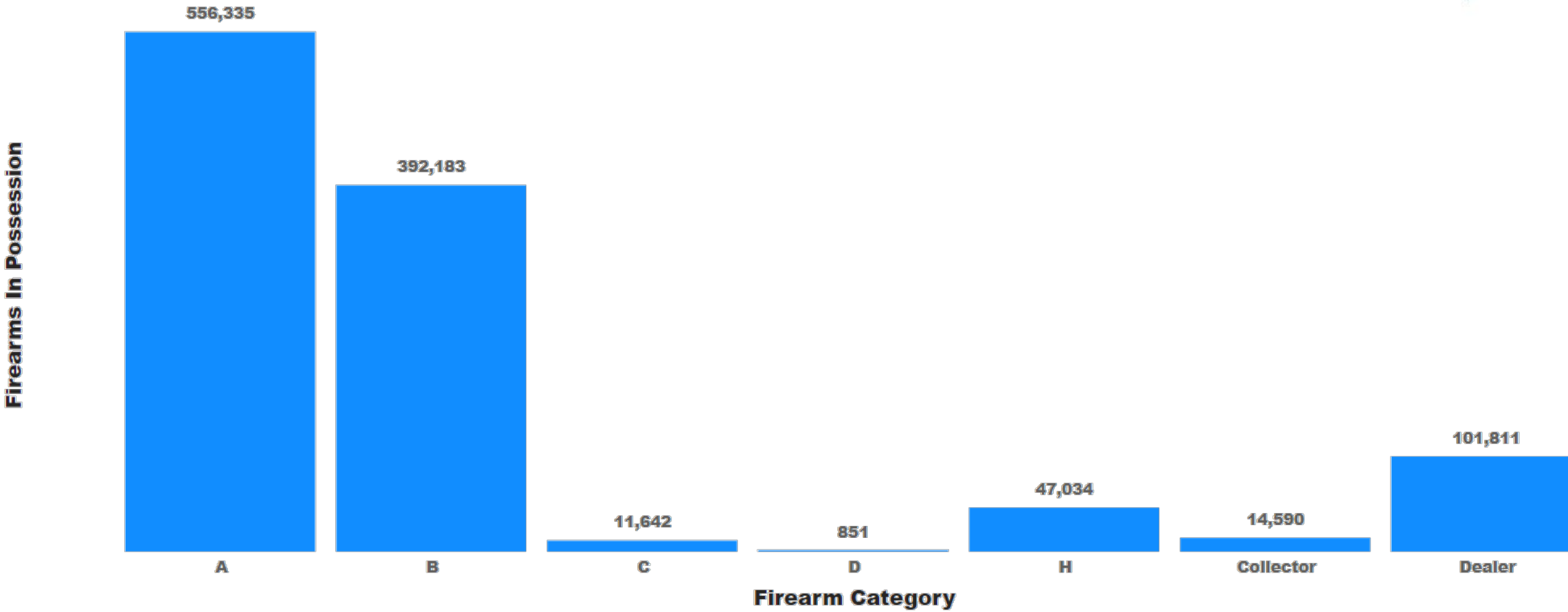
