#### CHECKLIST

Make sure you have supplied ALL of the following required information:

**All applicants are required to provide:**

- A completed P634** 'Application for a Firearms Permit' form
- Proof of Identity** (if no other NSW firearms licence or permit is held or has been held).
- A Legitimate Reason** form with the relevant sections completed:
  - Address / location and size of the business premises/land where the laser games/laser skirmish will be conducted
  - A certified copy of the approval to conduct the activities from the relevant local consent authority or person responsible for the control of the land / business premises
  - Details of the measures that will be taken to ensure that all activities are conducted with proper regard for public safety
  - Details of the imitation firearms to be used for laser games / laser skirmish
  - Details of the firearm safe keeping facilities
  - Police Inspection Event number
  - \$75 fee with the application**

**BUSINESS APPLICANTS ONLY** - A completed P635 for each employee to be authorised by this permit AND proof of identity for each employee (if no other NSW firearms licence or permit is held or has been held).
