## 1. LOCATION LASER GAMES/LASER SKIRMISH WILL BE CONDUCTED

Provide the address/location and a description of the premises/land where the laser games/laser skirmish will be conducted. A copy of the approval to conduct laser games/laser skirmish from the relevant local consent authority or person responsible for the control of the land/business premises must also be supplied.

Attach a copy of the approval to conduct laser games/laser skirmish from the relevant local consent authority or person responsible for the control of the land / business premises attached.

#### 2. PUBLIC SAFETY MEASURES

Provide detailed information below of the measures that will be taken to ensure that all activities are conducted with proper regard to the preservation of public safety.

#### 3. DETAILS OF THE FIREARMS TO BE USED

Provide details of the imitation firearms to be used for laser games / laser skirmish activities below. Include brand names, models numbers etc.

#### 4. FIREARMS SAFE KEEPING FACILITIES AND INSPECTION EVENT NUMBER

It is a serious offence under the *Firearms Act 1996* to make a statement or provide information in relation to an application that is false or misleading. By signing the Declaration on your firearms permit application form, you are certifying that ALL the information supplied in relation to this application is true and correct.

## CHECKLIST

Make sure you have supplied <u>ALL</u> of the following required information:

#### All applicants are required to provide:

- A completed P634 'Application for a Firearms Permit' form
- **Proof of Identity** (if no other NSW firearms licence or permit is held or has been held).
- A Legitimate Reason form with the relevant sections completed:
  - O Address / location and size of the business premises/land where the laser games/laser skirmish will be conducted
  - A certified copy of the approval to conduct the activities from the relevant local consent authority or person responsible for the control of the land / business premises
  - O Details of the measures that will be taken to ensure that all activities are conducted with proper regard for public safety
  - O Details of the imitation firearms to be used for laser games / laser skirmish
  - Details of the firearm safe keeping facilities
  - O Police Inspection Event number
  - \$75 fee with the application

**BUSINESS APPLICANTS ONLY** - A completed P635 for each employee to be authorised by this permit <u>AND</u> proof of identity for each employee (*if no other NSW firearms licence or permit is held or has been held*).
