#### All applicants are required to provide:

- A completed P634 'Application for a Firearms Permit' form
- **Proof of Identity** (if no other NSW firearms licence or permit is held or has been held).
- A Legitimate Reason form with the relevant sections completed:
  - Description of premises used for RSL
  - C Evidence of affiliation with the Returned Services League of Australia (NSW Branch), or a member of the RSL and Services Clubs Association Limited
  - Firearm safety training certificate, *if applicable*

Certification from the Secretary that the firearms are (or will be) of a kind used as weapons of war and any prohibited firearms will be rendered permanently inoperable or other firearms will be rendered temporarily inoperable.
