4 EVIDENCE OF AUSTRALIAN CITIZENSHIP / RESIDENCY / VISA STATUS

Licences can only be granted to Australian citizens, permanent Australian residents (including New Zealand citizens), or holders of a visa for a skilled occupation to which the activities authorised by the proposed licence correspond.
