# PROHIBITED WEAPONS INSTRUCTOR PERMIT

This fact sheet provides information on the requirements for obtaining a Prohibited Weapon Instructor Permit - clause 16 of the Weapons Prohibition Regulation 2017.

It is an offence in NSW to possess a prohibited weapon without the authority of a permit.

# What does the Instructor Permit authorise?

This permit authorises the possession and use of prohibited weapons specified on the permit for the purposes of instructing, training or competing in a sport or recreation specified in the permit.

Instruction may only be conducted at premises specified on the permit.

This permit also authorises persons receiving instruction or competing in the sport or recreation to possess and use the prohibited weapons specified on the permit, but only while under the direct supervision of the permit holder.

# Who can apply for this permit?

A person, or a person on behalf of a business whose ranking in the relevant sport or recreation qualifies them to instruct in that sport or recreation, and

- 1. Who is accredited as an instructor by an approved sporting organisation or body for that sport or recreation, OR
- 2. Is a registered training provider under the National Vocational Education and Training Regulator Act 2011 and who conducts a prohibited weapons training course that is accredited under that Act.

The applicant must provide evidence that it is necessary to possess or use the prohibited weapon for which the permit is sought to carry out instruction in the sport or recreation.

# What is the approved sporting organisation or body for accreditation?

To view the list of approved bodies please refer to the Instruments of Approval on the Firearms Registry website: https://www.police.nsw.gov.au/online services/firearms/permits/prohibited weapon permits/instructor. The permit will be issued for a maximum term of 5 years.

# What do I need to send with the application?

- A completed P638 'Application for a Prohibited Weapons Permit' form, and
- A completed 'Prohibited Weapon Instructor Genuine Reason' form, and
- A completed 'Business Declaration' (business application only), and

The information provided in the fact sheet is for general guidance only. Applicants

Supporting documentation as requested on the genuine reason form.

# How much will the permit cost?

The prescribed fee for this permit is \$127. Payment must accompany the application by filling out the credit card details on the reverse of the application form.

# How do I apply for a Prohibited Weapons Instructor Permit?

You must complete the P638 'Application for a Prohibited Weapons Permit' form and the 'Prohibited Weapons Instructor Genuine Reason' form and where applicable provide any supporting documentation. Please see the reverse of this fact sheet for instructions on how to complete the P638 form.

#### **NEW APPLICATION / REAPPLICATION**

Mark appropriate box (new application or reapplication). If you currently hold or have previously held a firearms licence or firearms or prohibited weapon permit enter your licence or permit number.

# **SECTION A - PERMIT TYPE**

From the drop-down list select the type of permit relevant to this application. If the permit is not listed in the drop-down list, enter 'Other' and describe the type of permit you require in the space provided.

# **SECTION B - NOMINATED PERSON / PERMIT HOLDER**

Insert the full name, date of birth, gender, NSW drivers licence (if held), contact phone numbers, email address and supply details of the nominated person (business) or nominated permit holder (individual). If you have been known by any other names enter your alias here.

# SECTION C & D - RESIDENTIAL/POSTAL ADDRESS

Insert your full residential address in this section. If the postal address is the same as the residential address, mark the box. If your postal address is different to your residential address, insert your postal address in this section.

# SECTION E - BUSINESS, CLUB OR GOVERNMENT AGENCY DETAILS

If this application is being made by a Business, Club or Government Agency, provide details in this section and attach supporting documentation.

# **SECTION F - SAFEKEEPING ADDRESS OF WEAPONS**

If the safekeeping address is the same as the residential address, select 'YES' in the box. If your weapon safekeeping address is different to your residential address, insert the address in this section.

# **SECTION G - PERSONAL HISTORY**

Answer each question by selecting a 'YES' or 'NO' from the drop-down list. If you answer 'YES' to any question, provide details as an attachment.

# **SECTION H - DECLARATION**

The application must be signed and dated by the applicant.

#### **SECTION I - FEE**

The prescribed fee for a prohibited weapon permit is \$127. Your payment must accompany the application.
